		<p><b><u>School specific arrangements</u></b></p> <p>EYFS bubble (Nursery/ Reception) – 22 pupils This bubble will work in the Home Room and Reception classroom as well as using the EYFS outdoor area. For some lessons the Nursery and Reception groups will split into two groups (R 9 pupils and N approx. 8-10 per day).</p> <p>Y1-4 bubble -33 pupils Pupils will work in separate class groups for most lessons but will join as Y1-4 bubble for playtime, lunchtime, Forest School and Swimming when it starts again.
